Re: Report of services rendered in settlement of vendor claim


Dear Commissioner Hisey:

This letter responds to your request concerning the reportable value of the services I provided without charge in order to resolve a vendor claim against your candidate committee. My legal services were provided to your committee without compensation as a volunteer. Article XXVIII, Section 2; para. (5)(b) of the Colorado Constitution specifically provides that the term "contribution" does not include "services provided without compensation by individuals volunteering their time on behalf of a candidate [or] candidate committee . . ." Therefore, the value of my services rendered for your committee are not reportable as a contribution either in cash or in kind.

If you wish to do so, you may file a copy of this letter with your campaign finance report to ensure that the Clerk and Recorder and the Secretary of State are aware that my services were provided as a volunteer to your candidate committee. If either the Clerk and Recorder or the Secretary of State has questions concerning this matter, please feel free to ask them to contact me directly.

As always, I appreciate your service and commitment both to your constituents and El Paso County at large and it was my privilege to assist you and your committee by volunteering my services.
