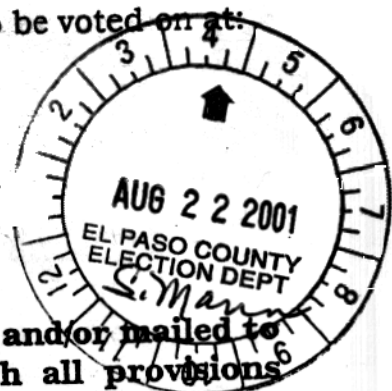
CANDIDATE AFFIDAVIT

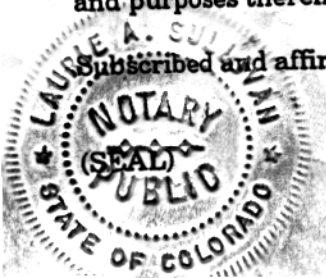

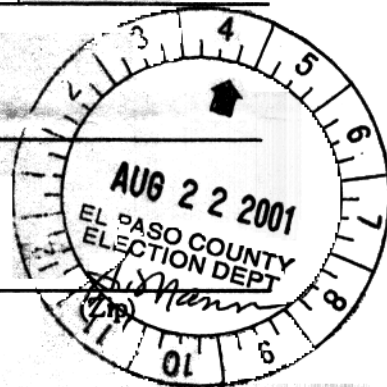
