Dear Glenn Lodwig,

A review of our files indicates that you have not filed required report(s) of contributions and expenditures. The Report of Contribution and Expenditure was to be filed on December 2, 2004 with the closing date for the reporting period being November 30, 2004. Colorado Revised Statute 1-45-108 (2) (a) (II) states that such reports that are required to be filed with the county clerk and recorder or with the municipal clerk shall be filed on the twenty-first day and on the Friday before and **thirty days after** the primary election, where applicable, and **the major election** in election years and annually in off-election years on the first day of the month in which the anniversary of the major election occurs.

Section 10 of Amendment XXVIII of the Colorado Constitution states that: "The appropriate officer shall impose a penalty of fifty dollars per day for each day that a statement or other information required to be filed pursuant to Section 5, Section 6, or Section 7 of this article, or Sections 1-45-108, 1-45-109, or 1-45-110, C.R.S., or any successor sections, is not filed by the close of business on the day due. The daily fine continues indefinitely until filing deficiency is remedied. The fine is being imposed as of December 3, 2004, the date of this mailing.

Colorado Revised Statute 1-45-108 (1)(a)(I) provides: "All candidate committee, political committees, issue committees, small donor committees, and political parties shall report their contributions received, including the name and address of each person who has contributed twenty dollars or more; expenditures made; and obligations entered into by the committee or party.

Until a termination report is filed, disclosure reports are required for all committees; however, please be aware that Secretary of State's rule 5.9 states that for purposes of section 1-45-108 (2) (d), which exempts a candidate committee for a former officeholder or person not elected to office from reporting if there is no change in the balance of funds resulting solely from the accrual of interest or dividends to the account and/or the automatic deduction of periodic service fees does not subject such candidate committee to the reporting requirements of section 1-45-108. Candidate committees that choose this option must notify, in writing the appropriate filing officer of their intent.

Reports may be filed by mail (Election Department, PO Box 2007, Colorado Springs, CO 80901) or personally delivered (200 S. Cascade) or faxed to (719) 520-7327. A hard copy must be received within 7 days of a faxed submission.


Please consider our Report of Contributions and Expenditures ending 10/29/04 ~~our~~ final report.
