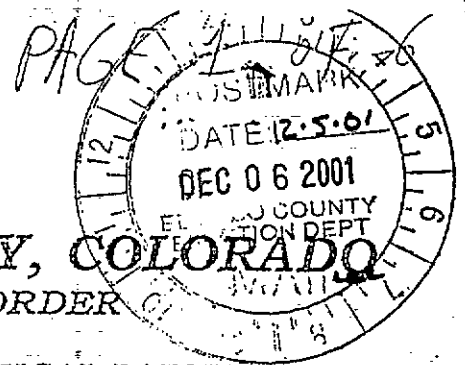

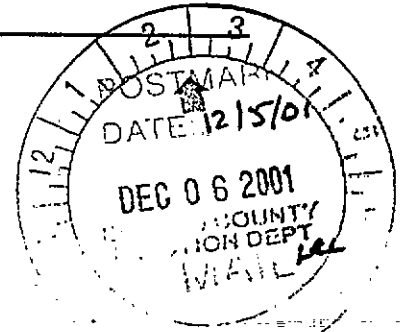

The Libertarian Party of El Paso County will inform you of the new Registered Agent after officer elections are held in mid January 2002.

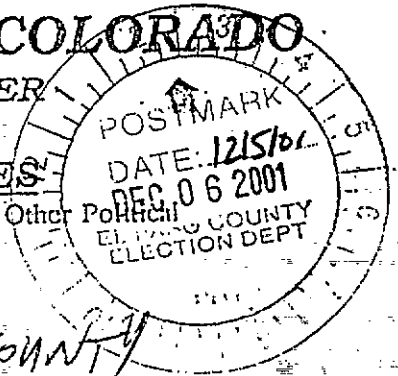

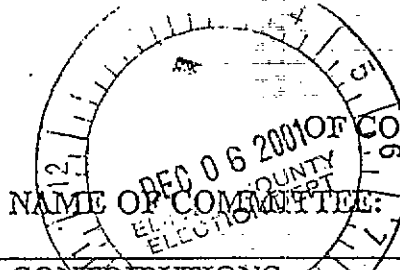

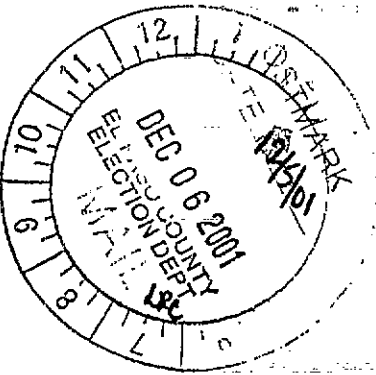
